#### **Product Information**

ULTIMATE PRINT MATT 4025 is a heat-sealable, printable PU-/PVC textile transfer vinyl (opaque white, 120  $\mu$ m) suitable for light and dark textiles.

ULTIMATE PRINT MATT 4025 is equipped with a low temperature adhesive with a transfer temperature of only 1140° F. Please note that a higher transfer temperature will have a negative influence on the surface of the vinyl.

ULTIMATE PRINT MATT 4025 offers a high print resolution with a semi-matt finish and has a pleasant soft textile touch. Due to a special top coat, the vinyl offers an excellent washing-resistance.

ULTIMATE PRINT MATT 4025 is compatible with all current printers using ECO-solvent and solvent inks. Due to a newly developed, non-adhesive PET film liner, even very small letters and motifs can be easily cut by all current CAD/CAM plotters after the printing process.

We recommend using POLI-TACK 853 as a transfer tape and as a protection cover during the heat transfer.

The transfer vinyl is used for motifs and logos on sport, leisure and work wear.

Nylon and textiles with a hydrophobic impregnation are not suitable for heat transfer.

## We recommend evaluation on test material.

Due to the various influences which occur from production and transfer of plotter letterings, consistency of the carrier materials and also washing and cleaning conditions, product liability can only cover the unprocessed material.
